1. In terms of SEBI (Share Based Employee Benefits and Sweat Equity) Regulations, 2021, CTIL Employee Welfare Trust (Trust) holds 1252480 equity shares of the Company in the name of trustees viz. Mr. Rupesh Joshi and Mr. Vinod Chaturvedi which was acquired through secondary acquisition on stock exchanges for the benefit of the eligible employees under CTIL Employee Stock Option Scheme 2023 (Scheme). However, Mr. Vinod Chaturvedi ceased to be trustee of the Trust and Mr. Anand Tripathi has been appointed as trustee of the Trust in his place. Further, the trustees of the Trust do not have voting rights in respect of the shares held by the Trust. The voting rights will be available to the individuals (Grantees) upon exercise of the Options by them under the Scheme.

2. Pursuant to the Scheme of Amalgamation, 75,60,900 (6.77%) equity shares held by the Umang Commercial Company Private Limited (Transferor Company) have stood transferred to and vested in Birla Group Holdings Private Limited (the Transferee Company) on 24th May, 2024. Accordingly, the Transferee Company i.e. Birla Group Holdings Private Limited has been categorized as a member of the Promoter Group of the Company in place of Transferor Company i.e. Umang Commercial Company Private Limited..
